If the Company does not receive the completed Reply Form or a response indicating an objection from you by 17 January 2018, you will be deemed to have consented to receiving the Website Version of the Corporate Communication and a printed notification letter of the publication of the Corporate Communication on the Company’s website will be sent to you in the future.

You have the right at any time by reasonable prior notice to the Share Registrar, in writing or by email to fdgev@unionregistrars.com.hk specifying your name and address, to change the means of receipt of the Corporate Communication. Even if you have chosen (or are deemed to have consented) to receive the Website Version of the Corporate Communication but for any reason have difficulty in receiving or gaining access to the Corporate Communication, the Share Registrar will promptly upon your request send the Corporate Communication to you in printed form free of charge.
